SONGS FOR SYRIANS PROVIDES INSTRUMENTAL MUSIC INSTRUCTION USING RECORDERS AND PERCUSSION AND TRAINS STUDENTS TO PERFORM IN ENSEMBLES. THE PROGRAM CURRICULUM INCORPORATES BOTH LOCAL AND INTERNATIONAL MUSICAL TRADITIONS.
