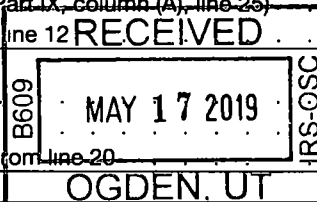

The Blue Lips Foundation works to bring patients of pulmonary hypertension to early and accurate diagnosis. The disease is often misdiagnosed or under diagnosed, leading to delays in treatment. Delays are generally up to two or more years after symptom onset. Poor diagnoses rates for patients of pulmonary hypertension lead to irreparable harm to the heart and lungs, often leading to heart failure and premature death.

In 2018, the Blue Lips foundation committed \$100,000 toward early pulmonary hypertension detection research to be performed in a joint venture between the Minnesota Heart Research Institute and the Mayo Clinic seeking benchmark profiling in PH patient candidates. The funding was committed with a \$50,000 grant payable in 2018 and a second \$50,000 grant payable in 2019.

In 2018, the Blue Lips Foundation launched its "Beyond Blue Lips" initiative to provide non-medical cost grants to qualified PH patients and their caregivers. Funding for the program commenced in 2018, and grants are expected to be awarded in 2018.
