**Monitoring of Funds Accounting Methods**

The Mount Ararat Discovery Foundation (MADF) has been established to seek out, document, and scientifically test, study and preserve artifacts found within or connected with the discovery of an ancient wooden structure on Mount Ararat that natives of the region have believe to be the remains of the Noah's Ark. Genesis 8: 4-5 points to the mountain as the landing place of the Ark.

Turkish native, Ahmet Ertugrul (Parasut) made this discovery in 2008 using information provided by his relatives who had lived on the mountains until shortly after WWI, but who now life in the neighboring countries, owing to the civil war in the areas. Until recently, political and military conflicts in this area prevented the families from sharing the secrets of the mountain whcih they carried with them into exile.

The archaeological investigation of this study is being connected by Dr. Oktay Belli, formally head of the Department of Ancient Near Eastern Archeology of Istanbul University and one of the world's most distinguished authorities of the Ararat region. Dr. Belli conducts a biannual Symposium on Mount Ararat and Noah's Ark.

Parasut's long search for the discovery using information provided by his family was funded by Hong Kong based Noah's Ark Ministries Internatonal (NAMI) and was announced to the world in April, 2010. Clara Wei, a science writer for Hong Kong public television has long served as Parasut's spokesperson and business partner. Parasut and Clara's Epictudio LTD serves as the conduit for MADF to process grant money for the project. Non profits will be established in the Republics of Turkey and Georgia which MADF will support.

Epictudio LTD and others working as partners with Epictudio LTD and MADF have considerable proprietary interest in the artifcats and in testimonies from those who have witnessed, obtained and preserved these artifacts. The invoices associated with these expenditures and paid by MADF in part reflect these proprietary interests.

Epictudio LTD invoices MADF for specified activities with fees that are negotiated between MADF and Parasut. While there are many uncertainties due to political and military conflicts in the area, conditions on the mountain, and other situations that might threaten execution, MADF closely monitors the results obtained from our funding to be sure that our foundation's functions are being advanced.
