To address the first priority of increasing awareness of and access to multi-lingual healthcare services and culturally competent providers, OMCI began by focusing on current language access services and increasing utilization of those services. The goal for 2017 was to increase the number of patient contacts with language access services by 5% over 2016. That goal was met with an increase of 9%. In 2018, the goal was to increase the number of patient contacts by 5% over 2017. That goal was not met due to a slight increase of patient contacts by 0.15%. The second response to address this priority was to partner with the Deaf Cultural Center and participate on the Deaf Community Health Literacy Planning Committee focusing on providing educational resources and free health screenings to the deaf community. The goal for 2017 was to increase the number of workshop and health fair participants by 20% over 2016. This goal was not met and actually decreased by 15%. In 2018, we saw a dramatic decrease in participation in these events. Our goal was to continue to increase participation by 5% over 2017. There was a 50% decrease in participation in 2018. We continue to see a lack of support from the Cultural Center and involvement in the Deaf Health Literacy Task Force. This continues to impact these workshops because attendance at the workshops is primarily due to the lack of support from the Cultural Center by way of committee participation and grass roots promotion within the deaf community. Additional efforts to support this priority include OMCI's leadership involvement in the Olathe Latino Coalition and Hispanic Community Task Force. Both of these groups are focused on providing guidance and resources for those within the Latino community. The second priority is to improve access to behavioral health services, including case management, diagnostic services, overcoming stigma, funding and placement. The first response to address this priority is to continue a partnership with Kids TLC to provide licensed psychologist and other staff embedded in the Olathe Health Family Medicine clinics. A new provider was added in 2017 at a second location. The goal for 2017 was to increase the number of patient encounters with Kids TLC providers by 25% over 2016. OMCI missed that goal by 2%. In 2018, the goal was to continue to increase awareness about this program and increase access. This goal was met with a dramatic increase of 143%. The second response recognized our partnership with KVC Health Systems to expand access of psychiatric consults for patients in the hospital, in crisis. The goal for 2017 was to increase the number of psychiatric</p>

In 2018, the goal was to increase the number of inpatient consults by 5% over 2017. There was a decrease of 3%. This goal was not met. Several additional efforts were completed to better address this health need. Within the primary care clinics, each patient, age 12 and older, undergoes a depression screening using the standardized tool called the PHQ-2. If patients score anything other than a zero then a full PHQ-9 (9 question standardized tool) to further evaluate the patient's symptoms. Patients with known depression are followed for depression management and follow-up occurs every 4 months. OMCI's emergency department also provides a major depression and suicide risk screening process. OMCI also developed a behavioral health resource guide that is distributed through community outreach events and within the primary care clinics. OMCI financially supports the Olathe School District to provide students access to mental health therapists at Olathe North High School and Sante Fe Trail Middle School. These funds also support the Student Health Emergency Fund, which helps students and families access medications they need to be successful in the classroom. OMCI partnered with Gateway of Hope, which is designed for women in our primary service regarding the triggers, signs and effects of depression, anxiety, stress and trauma. Priority three was to address the obesity rate in our community by changing healthy eating and physical activity behaviors through interactive education, access and policy. The first response was to partner with the city of Olathe Parks &amp; Recreation department to launch the app called Get Active. The goal for 2017 was to financially support, gather resources and create the online app for the Get Active. In February of 2018, the app launched and saw a total of 1,200 downloads with an 84% usage rate in its first year. OMCI continued to participate in the promotion of the app, and also sponsored challenges within the app to encourage healthy eating and positive behavior change related to eating and exercise. The second goal is to increase the number of diabetic patients who have a hemoglobin A1C under 9. In 2017, 29.5% of diabetic patients were hitting this metric. In 2018, there was a 4% increase in the number of patients with an A1C lower than 9. The third response to this priority was active participation within Johnson County's Food Policy Council. OMCI actively participated in various subcommittees of the council including food insecurity in the healthcare setting, food waste and pollution prevention, along with the hunger summit. Additional efforts supporting this priority include support of the Olathe Community Garden program, providing health education classes at the Olathe Community Center and at OMC. OMCI offers a number of services to the community including access to dietitians, diabetes education and bariatric treatment for those who meet the criteria. OMCI also financially supports programs in the community that address this health need through the Olathe School District, local races and an outdoor fitness center. The fourth identified health need was access to affordable care. After further discussions with the community and its stakeholders, a number of resources were identified. However, there was a lack of awareness about these resources to better support the community. Therefore, OMCI's response to this priority was to increase awareness of existing services across the community. In 2017, the goal was to distribute a survey to establish an understanding of baseline awareness level of supportive resources in the community by Dec 31, 2017. On Oct 25, 2017, an Access to Affordable Care luncheon was held and the survey was launched on Nov 29, 2017. The baseline awareness of supportive resources within the community was 37%.
