for free bike repairs to community; maintained 4 miles of natural surface
walking trail (Rozarks); supported access to healthy food through 4 community gardens
and the Rosedale Farmers Market. Collaborated with Healthy Communities Wyandotte
Initiative. Expanded participation in youth programs, community gardens and community walking club.
