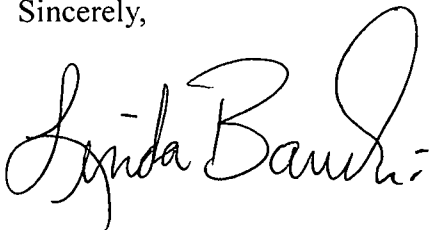
This letter is in response to LTR 2695C dated January 21, 2020. Attached is the Schedule A requested in this letter along with the re-submission of the original 990 EZ.
