Three watershed restoration and protection programs, two above the federal reservoirs of Perry Lake and Tuttle Creek Lake, that provided cost-share financial assistance to private landowners to address surface water pollutants that affect the water quality of the watersheds and federal reservoirs. Pollutants reduced included sediments, nutrients, bacteria, livestock waste which affects public drinking water supplies. A total of \$135,880 in cost-share funds were paid to private landowners to install conservation practices to reduce pollutants loads from reaching the two federal reservoirs and the Missouri River.

- 4b** (Code:) (Expenses \$ 266,340 including grants of \$) (Revenue \$)
Regional economic development and small business development program provided training, workshops, business planning, and financing to entrepreneurs starting small businesses and existing business owners wanting to expand their growing businesses. Over 160 people were assisted and over 40 jobs were created or retained. The Glacial Hills Food Center, a shared-use commercial kitchen food processing facility provided space and equipment for five food entrepreneurs. The Glacial Hills Business Resource Center provided support and assistance to entrepreneurs and small businesses with business planning, meeting space for workshop, and leases office space to 16 businesses. The program is a public-private partnership with the Washburn University Small Business Development Center, local economic development commissions and chambers of commerce, banks and local elected officials. The Shawnee Co. e-Community is a program with Network Kansas which provides loan funds and workshops for entrepreneurs and businesses. Two businesses received loans to start their businesses which created 10 new jobs.

The Delaware River Streambank Restoration Program addressed the issue of streambank erosion that produces sediment and other nutrients that are deposited into Perry Lake, a federal reservoir that provides public drinking and flood control for the population of eastern Kansas. The lake is silting in with sediments from farmland and streambank erosion that reduces the capacity of the lake to hold public drinking water. The program identifies hot spots on the river that need to be restored and re-established with riparian forest buffer along the river. The program cooperates with the Kansas Dept. of Agriculture, Division of Conservation; Kansas Water Office; Kansas Dept. of Health & Environment and the Kansas Forest Service which provide funds for design and construction of restoration projects. Two projects were completed and two more will be under construction in 2019.
