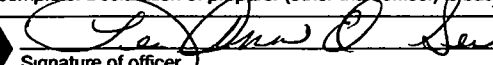

We have always filed a 990 N (Postcard) in the past. This year we inadvertently missed the deadline on the 990N, and when the Director received the late notice from the IRS, she hurried to correct it. However, in the preparation, she read the regulations more closely and determined that we may have been filing the wrong form. The bulk of our funding comes from the County and City as support, and we had previously understood that the \$50,000 threshold was only for funds received OUTSIDE of the City and County support of which we had not had much before. Recently, we were able to receive additional grant funding through Network Kansas, and even make small business loans to start-ups through Network Kansas -- and in wanting to report that correctly, she realized the potential reporting errors of the past.

We are also asked to promote the community as a good place to live, work and play in numerous publications, at trade shows, and within the community.
