Form 990, Part III, Line 4a America needs an agricultural industry that supports healthy rural communities, protects the environment, and promotes a safe, diverse, and stable food supply. To achieve these goals, America needs a healthy family farm-based system of agriculture. Targeted, top-notch legal information and advocacy are indispensable in the struggle to defend family-based agriculture and secure social and economic justice for farmers. To provide this service the Kansas Farm Bureau Legal Foundation (Legal Foundation) used more than 20 volunteers.

Form 990, Part III, Line 4a The Legal Foundation contributes funds to both Kansas State University and Washburn University School of Law to help promote agricultural law education and outreach within the state, and specifically, with hopes of returning highly trained agricultural lawyers back to rural parts of the state. The Legal Foundation also partnered with Kansas State University and Washburn University School of Law for the third annual Agricultural Law and Business Symposium. The Symposium educates legal and tax practitioners on current agricultural law, taxation, and economic issues, so they are better able to serve farmers and ranchers. The Symposium has been attended by over 275 persons in just the first three years.

Form 990, Part III, Line 4a The Legal Foundation joined efforts with other agricultural groups to intervene in a gas rate case at the Kansas Corporation Commission. The need for intervention arose when we realized agricultural irrigators reliant on gas to power their irrigation systems could be disproportionately bearing more of the rate increase than their fair share. The advocacy provided by our attorney and hired rate expert successfully reduced the impact to irrigators affected by this gas rate increase, and provided a framework by which future gas rate cases can be more fairly decided, requiring more complete information to be provided by the gas company about its cost of providing service to irrigators.

Form 990, Part III, Line 4a The Legal Foundation has financially contributed to an effort by several state Farm Bureau organizations to research and develop a response to issues regarding

agriculture and the Endangered Species Act. These efforts have focused on educating our members so they are aware of these issues and informed of the available practices that can be adopted to promote preservation of different species, compiling information that can be written into state-wide species conservation plans, and communicating to federal agencies that will make the ultimate listing decision regarding the condition and outlook for various species.

For each interest disclosed to the President, the President will determine whether to (A) take no action, (B) assure full disclosure to the Board of Directors and other individuals covered by the policy, (C) ask the person to excuse themselves from participation in related discussions or decisions within the organization, or (D) ask the person to resign from his or her position in the organization. If the person refuses to resign, he/she would become subject to possible removal in accordance with the organization's removal procedures. The organization's CEO/General Counsel will monitor proposals or ongoing transactions for conflicts of interest and disclose them to the President in order to deal with potential or actual conflicts, whether discovered before or after the transaction has occurred.

comparables exist). The market ranges represent a 50% spread from the minimum to the maximum

of the range and are evaluated annually. If the market shows an increase of more than 5%, the

increase in the ranges are capped at two times the annual salary budgeted increase. If the

market shows less than a 5% increase or a market decrease, the ranges remain the same for the

upcoming year. In addition to base compensation, these positions are also eligible for

incentive compensation, paid according to the employee's performance and the financial health

of the organization.
