Payments to providers and minor administrative costs to pay the partial cost of abortion care for Wisconsin residents to help ensure access to safe, legal abortion. Women's Medical Fund (WMF) supported 975 people in 2018 with an average of \$378 each paid directly to medical providers after completion of the procedure. The average recipient is in her 20s, is already a mother, is unmarried, receives Medical Assistance (which does not cover abortion), is a high school grad, was not receiving help in paying for the abortion from the man involved, & was less than 12 weeks pregnant. Over 80% of callers are already mothers; most have 1 or 2. The youngest helped was 13, the oldest 45. Almost half of callers came from Milwaukee, the rest came from over 145 cities & towns throughout Wisconsin. A majority of recipients qualified for food stamps and/or other public assistance. WMF is hearing from an increasing number of people who are homeless, some of whom are bouncing from family to friends, often after eviction, especially in Milwaukee. All funds expended went to directly help Wisconsin residents cover the cost of abortion, with less than 1% of donated non-restricted funds spent on administrative costs. WMF has been a volunteer organization for 47 years.
