Encore Fellowships Program In partnership with Encore org, SVP managed the Encore Fellows program in Los Angeles County beginning in 2014, sunseting involvement December 2017, with two remaining grants that were made in January 2018 to close the program. The Fellowship program was designed to bring new sources of talent to social-purpose organizations by tapping highly-skilled, seasoned professionals (20+ years of experience) who are retiring or transitioning out of their career, and who want to utilize their skills to contribute to the greater good. Although the impact was significant, the SVP board felt it was not in a position to scale the program.
