NSSLHA follows guidance that clarifies the accounting for uncertainty in tax positions taken or expected to be taken in a tax return, including issues relating to financial statement recognition and measurement. This guidance provides that the tax effects from an uncertain tax position can only be recognized in the financial statements if the position is "more-likely-than-not" to be sustained if the position were to be challenged by a taxing authority. The assessment of the tax position is based solely on the technical merits of the position, without regard to the likelihood that the tax position may be challenged. For the year ended December 31, 2018, NSSLHA reported unrelated business income tax, for federal and state purposes, which is immaterial for financial statement purposes. The adoption of ASC 740-10 did not have a material impact on NSSLHA's financial statements, as management determined that there are no uncertain tax positions within its financial statements.

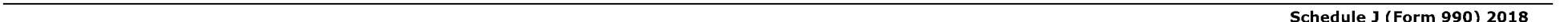
