Cultural Diplomacy (Turkey): HasNa and SIMS Dernegi based in Gaziantep, Turkey have collectively worked on a cultural project aimed at youth development in southeastern Turkey. This collaborative project seeks to set up the first Turkish-American cultural exchange center in the city of Gaziantep, that will give young people access to a library, study abroad resources, career guidance, and a platform to facilitate a rich exchange of ideas and information on the history, arts, and culture of Turkey and USA. We prepared for the project along with our local partner in Gaziantep, applied to the U.S. Embassy in Ankara during two funding cycles in 2018. We are currently awaiting a response from the Embassy before launching the next phase.

4b (Code:) (Expenses \$ **33,095** including grants of \$) (Revenue \$)

Distance Learning: HasNa launched an online course on Peace Education in Classrooms, focused on training educators, activists, and NGO professionals on mainstreaming various aspects of peace education into their formal and non-formal education sectors. HasNa partnered with TechChange and licensed their online teaching platform for uploading content and hosting live events. We conducted two live webinars: the first on "Introduction to Peace Education" and the second on "Gender Equality in the Classroom" where we had guest speakers share best practices with our online participants. We are continuing to grow this program and to host more webinars and add content to the online course for our beneficiaries.

Domestic Workshops: HasNa partnered with Meta-Culture, a Washington, DC-based conflict management nonprofit, to launch a series of community discussions or workshops on various aspects of democracy and civic responsibility. This series, titled "DemoSapiens" was the first of HasNa's domestic projects, intended to start local conversations on important issues that have a direct influence on people's lives. The aim of these workshops was to encourage dialogue among community members holding different opinions and perspectives, thereby promoting understanding and empathy between them. HasNa and Meta-Culture hosted three workshops on "The Rise of Authoritarianism," "Immigration," and "Freedom" respectively.
