During 2018, the Sudan Relief Fund (Organization) sent funds to five different dioceses in South Sudan and the Sudan Catholic Bishops Conference for operations and capacity building for churches, schools, and an orphanage. The Organization funded the operation and maintenance of a hospital in the Nuba Mountains to include supplying medicines and medical supplies, staff salaries, and staff training. The Organization funded United States and foreign organizations to provide services to the people of South Sudan. The Sudan Relief Fund advocated for the people of South Sudan by raising awareness of their situation through mailings, videos, and public events in the United States. The Sudan Relief Fund sent funds for humanitarian aid to help alleviate the suffering of the more than two million refugees from the civil war that erupted on December 15, 2013.
