TO BUILD A MORE JUST AND INCLUSIVE FOOD SYSTEM. WE PARTNERED WITH THE NATIONAL FAMILY FARM COALITION AND FAMILY FARMERS IN IOWA TO DOCUMENT WHAT'S HAPPENING TO THEIR COMMUNITIES.
