Communications and Public Education Program In 2018, NTI continued its public education initiatives primarily through maintenance of an extensive online library that includes interactive maps and models, tutorials, and infographics related to the risks and threats from nuclear, biological, radiological, and chemical weapons, and through the issuance of various publications, including NTI's Rising Nuclear Dangers series. During the year, NTI launched an on-the-record seminar series, which features leading global security experts, authors, and industry professionals sharing their perspectives and expertise. NTI released a video and interactive microsite to bring biosecurity messages to non-expert audiences. These tools illustrate the risk factors and vulnerabilities in countries around the world that could lead to a biological event with staggering consequences. NTI also released the annual Global Incidents and Trafficking Database, which identified incidents of nuclear and other radioactive materials being lost, stolen, or out of regulatory control. This interactive database is the only comprehensive, public dataset available and it underscores the vulnerability of some nuclear materials. Another significant public education release was a detailed interactive that provides the most comprehensive publicly available explanation of arms-control verification procedures ever developed. NTI's Communications and Public Education program also continued to place high-profile op-eds and generated numerous TV appearances by Ernest Moniz, Sam Nunn and top NTI staff, advancing policy recommendations on topics including US-Russia relations, North Korea, Iran, biosecurity and more. Outlets included The Washington Post, CNN, MSNBC, The New York Times, The Hill, and Health Security.

Biological Policy and Programs (BIO) 2018 was a year of major investment by NTI in enhancing global biosecurity. BIO worked to raise the profile of biosecurity in global health forums, identify gaps in countries' capacities to mitigate the effects of a high-consequence biological event, identify steps to reduce risks associated with advances in technology, and more. The program launched the NTI Biosecurity Innovation and Risk Reduction Initiative, a multiyear project that seeks to identify, develop, publicize, and promote actions to reduce global catastrophic biological risks associated with advances in technology. The program also launched a Global Biosecurity Dialogue and began developing a Global Health Security Index. The Global Biosecurity Dialogue brings together senior government officials to identify ways to prioritize addressing biological risks, and the Global Health Security Index will draw on publicly available information to assess country preparedness for pandemic threats.

Public Charity "Facts and Circumstances" Narrative for NTI's 2018 Form 990 Schedule A Filing NTI normally receives a substantial part of its support from the general public. NTI also meets the pertinent factors set forth in Regulations Section 1.170A-9(f)(3) as follows:

TEN PERCENT SUPPORT LIMITATION. NTI anticipates that its public support will continue to exceed 10 percent as has historically been the case.

ATTRACTION OF PUBLIC SUPPORT. NTI receives support from a number of individual donors, foundations and public charities. NTI intends to continue soliciting support through various means, including through its website and by distributing information useful to the public.

PERCENTAGE OF FINANCIAL SUPPORT. As noted above, NTI expects that its public support will continue to exceed ten percent, as has historically been the case. Public support percentages over the last several years were: 15.89% in 2014, 20.73% in 2015, 20.3% in 2016, 21.2% in 2017, and 19.91% in 2018. 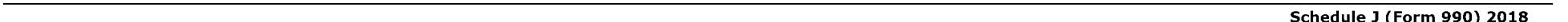
