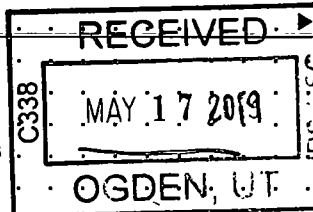

Part I, Line 10, Grants \$18,093

In 2018, FDR made several small grants, either to the Peace Corps Partnership Program, at Peace Corps Washington, or to entities in the DR working closely with Peace Corps DR, to pay for small-scale infrastructure projects in rural communities in the DR. We also provided publishing software to enable production and printing of materials for Volunteers, including two printings of an environmental manual for use by Volunteers and students active in local environmental chapters of the Brigada Verde movement (Green Brigade). We funded three workshops in conjunction with the National Environmental School.

Part 1, Line 16, Other Expenses \$1375

These expenses are typically administrative costs for web hosting, content updates for our website, software updates, Pay Pal fees and small contracts, e.g., for email services. Also includes annual fee charged by Virginia Corporation Commission to maintain our status.

Part 1, Line 20, Other changes in net assets or fund balances -\$32,199

This net loss in asset value was reported to us in quarterly statements by American Funds and by the brokerage firm where we have one donated stock in our account. The numbers were taken directly from the quarterly statements for 2018.
