PFS trained 15 local area managers, who accompany patients to the surgical teams and help at medical evaluation missions. Regular Planning Meetings were held with all the local area managers throughout the year. 5 medical evaluation missions were completed, during which North American medical personnel evaluated and provided medical treatment to over 2,166 potential surgical patients. By Dec 31, 2018, our 15 local area managers, using 20 community radio stations and a national station, did approximately 100 radio programs on health, educating the rural population about surgical care opportunities in order to lower the perceived risk of having surgery. Partner for Surgery enabled the activities of 14 surgical teams, during which 1,045 patients were assisted. PFS continued its collaboration with the Guatemalan nonprofit Asociacion Compañero para Cirugia. In the interest of developing a sustainable process in Guatemala as well as of promoting and strengthening Guatemalan nonprofits, PFS made grants to Asociacion Compañero para Cirugia. In 2018, PFS continued a Cervical Cancer project, leading 2 weeks of training in Cervical Cancer prevention for 50 Guatemalan Ministry of Health nurses. In 2018, PFS continued a Nutrition Project, providing cleft infants in danger of death with nutritional supplements and providing sanitation training to the parents. By Dec 31, 2018, 311 children were assisted through this Nutrition Project, and 365 corrective surgical procedures were performed.

In addition, Partner for Surgery trains local government nurses to screen women for problems that could lead to cervical cancer, and trains community members to provide cleft newborns with nutritional care
