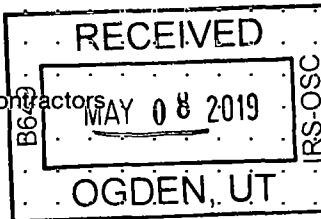



To provide a network of support to survivors of pediatric cancer through advocacy and support groups in the community, funding to support research, and educational programs, educational support and access to resources that enhance the quality of life of pediatric cancer survivors, while minimizing cancer's long-term effects.
