OTHER ACTIVITIES SUPPORTED BY OUR FUNDS INCLUDED SHABBAT DINNERS (350/WEEK), AND BAGELS ON THE LAWN (150/WEEK). -CONGREGATION BETH ISRAEL (CBI) 35,981.
