Part II Line 1	CCF grants funds to Camden-Clark Memorial Hospital based on board approval to release the funds from restriction and transfer them to the hospital. When funds are received by the Foundation for a particular purpose, they are held by the Foundation until proof is provided to the board that the purpose is met. This may involve completion of a construction project, purchase of equipment, etc. Once the hospital is able to furnish such proof then the restrictions are lifted and funds are transferred. This represents the most significant portion of the Foundations grant activity.
Part III Line 1	In addition, on an annual basis, funds are granted for scholarships in two ways. Scholarships are granted out of the Carsner fund to anyone in a medical health profession. Candidates submit applications and the scholarship committee of the auxiliary then determines who will receive a scholarship based on their review of the candidates. The number and amount of the scholarships is based on the investment performance of the Carsner fund during the year. In addition, CCMH has a nursing alumni group from its former school of nursing. Once again, applications are submitted by the candidates and are reviewed by the nursing alumni. Two scholarships are granted to individuals currently in an RN education program. The amount of funding provided is based on the amount of donations received during the year for this purpose. The Foundation is not at all involved in the decision as to who receives the scholarship.

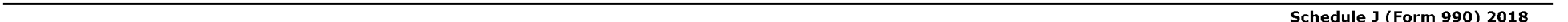
