Friends of Blackwater - We communicated with our membership through our website, quarterly newsletter, monthly E-News, direct mail, Facebook and Twitter. We hosted speakers and ran tours of the Blackwater area. We managed our central office in Thomas, WV where we participated in local events, ran roadside clean-ups and gave talks on our projects. We kept accounting records of individual donations and grants and expenses by project and other administrative duties. We continued to work on protecting Blackwater Canyon and began a campaign to stop industrial development on the edge of the Canyon. We took part in the Tucker Foundation Run for It Race and had booths at the Cheat Fest and the Forest Festival.

4b (Code:) (Expenses \$ 118146.46 including grants of \$ 0) (Revenue \$ 107221.82)
Blackwater/Northfork Watershed - The North Fork of the Blackwater River flows along the Blackwater Canyon Rail Trail and is negatively impacted by acid mine drainage (AMD) pollution from old underground mines. We received a grant from the WV Dept of Environmental Protection watershed program to re-engineer a water treatment facility on the North Fork and hired an engineering firm to design the new AMD treatment system in the footprint of the old one which no longer works and is located in the Monongahela National Forest. We began writing a Watershed Based Plan for Beaver Creek of the Blackwater River with funds from the WVDEP grants program.

Climate Change - With a grant from the Appalachian Stewardship Foundation we continued our partnership with HSTA (Health Science and Technology Academy). We presented climate science information to their afterschool high school clubs and at their summer camps. We planned and presented a major conference in partnership with the West Virginia Law School in December attended by 200 people with widespread media coverage.

Monongahela National Forest/WV Public Lands/Endangered Species - We continued to advocate for the rare West Virginia northern flying squirrel under the Save Our Squirrel (SOS) Project. "Ginny" the flying squirrel is the most unique mammal of the Allegheny Highlands and the signature species of Blackwater Canyon. We pushed back against logging in state parks that could hurt rare species and was not supported by the public. This proposal was defeated at the West Virginia Legislature. We also challenged commercial logging on the Canaan Valley National Wildlife Refuge and solicited comments on this proposed action. The proposal was withdrawn. We went to Washington DC to discuss initiatives that could undermine the Endangered Species Act (ESA) with Congressional Representatives and educated the public about the ESA and the Land and Water Conservation Act. Expenses - \$15399.01 Grants - 0 Revenue - \$38785.00

Blackwater Canyon Trail Project - We spent a third year consulting with the USDA Forest Service on plans to trail improvements and maintenance on the Monongahela National Forest. We wrote grant proposals for trail work and developed partnerships to expand our trail work into neighboring counties and into the state of Maryland along the North Branch of the Potomac River.

Expenses - \$18316.13 Grants - 09 Revenue - \$0

History of JF Clifford and Tucker County Railroad Heritage - Through our JR Clifford Project's new website and Facebook page we educated citizens about West Virginia's first African-American lawyer. We continued distributing our book on JR Clifford's life to schools across the state. We contracted with West Virginia Culture and History to create a highway marker at Hendricks explaining the engineering wonder of the Western Maryland Railroad grade built in 1888 through the Blackwater Canyon. We partnered with the Tucker County Historical Society on this project. Under a grant from the West Virginia Humanities Foundation we worked with the Forest Service Archaeologist to place five interpretive signs on the railroad history along the rail trail near Thomas, WV. We hosted two lectures on this topic in Thomas, WV.
