Other	Our Forests Aren't Fuel (OFAF) -Policy makers in Europe and the United States are promoting the burning of wood as a "renewable" climate friendly alternative coal for electricity generation under the guise of "renewable energy" even though the science documents that burning wood releases more carbon than coal per unit of electricity generated and further degrades forests. Over the past five years, the forests of the Southern US have been the target of this growing global market. In response, in 2013 Dogwood Alliance, launched the Our Forests Aren't Fuel campaign educating and activating citizens, policy makers and industry on both sides of the Atlantic to stop the further expansion of this industry. This campaign continued to be a major focus of work in 2018 leveraging significant results. A major focus of our efforts were focused in NC, ground zero for the expanding wood pellet industry. In an effort to stop the world's largest wood pellet manufacturer from expanding production in NC, we mobilized 40 state-wide organizations to sign a letter to NC Department of Environmental Quality, generated over 500 comments on the permit application, leveraged the support of 10 partner organizations to turn out to a public hearing on the permit, and generated media with a reach of 35 million. In addition, we released ground-breaking research with Tufts University on the environmental justice impacts of wood pellet manufacturing facilities and documenting that 100% of the mills in North Carolina were sited in environmental justice communities. This research was published in a peer reviewed Environmental Justice journal, This report was referenced in a NY Times Op-Ed on the impacts of industrial scale biomass and the media release for the brief was picked up by over 60 outlets across the country. Our work, in combination with other organizations pressuring the Governor on issues related to climate change helped secure the Governor's signing of an Executive Order on Climate Change, as well as the establishment of an Environmental Justice and a Natural and Working Lands stakeholder advisory groups, on which we were invited to participate. In addition to focusing on North Carolina, we also continued our work with partners in Europe to change the policies driving the wood pellet export market. Dogwood Alliance attended the United Nations Conference on Climate Change and met with advocates from around the world to strategize about how to stop biomass. We presented to an international audience of over 100 policy makers and nonprofit organizations from 36 countries. This work helped catalyze the development of a world-wide international biomass network. In addition we completed another "on the ground" investigation of Enviva's logging practices in North Carolina and Virginia with a major British media outlet. The investigation which documented Enviva's sourcing of wood pellets from clearcut wetland and hardwood forests was aired on the internationally acclaimed telev

Other	ision program Dispatches on Channel 4 in the UK. The Dispatches program was watched by nearly a million viewers in the UK and the related Facebook video received nearly 250,000 views. The program and our investigation received several public responses of concern from British politicians, this has aided in shifting public awareness of the issue in the UK. This work, helped to leverage a major shift in policy in the United Kingdom, who is a leading importer of wood pellets manufactured in North Carolina, which in effect stopped two proposed biomass facilities (which would have burned 48,000 acres of Southern forests annually) as well as any future industrial scale biomass power stations in the UK.

In 2018, we continued to play a major leadership role, chairing the coalition of over 50 organizations from 14 states across the South, helping to coordinate working groups and organizing two in-person two-day meetings. This resulted in agreement among the steering committee on a comprehensive strategy for advancing the protection of wetland forests that the coalition will begin implementing in 2019. Outreach to community groups and organizations across the South resulted in 66 new signatories on the WFI platform. Dogwood also finalized an ecosystem services report documenting that standing Southern wetland forests provide over \$500 billion in ecosystem services and that the value of these ecosystem services is 15 times their value for wood products. Media generated from this report had a reach of 35 million.

Other	Forests and Climate (F&C) - The Paris Climate Agreement gave the world a charge decarbonize all energy sectors and simultaneously remove carbon dioxide from the air. The best and most cost-effective technology we have to remove carbon from our atmosphere right now lies in the power of forests. Standing forests are the natural life support that we need to mitigate the worst impacts of climate change and protect those most profoundly impacted, often low income communities and people of color. Logging in the US releases large amounts of carbon into the atmosphere while simultaneously degrading the nation's forests ability to provide critical climate benefits. Despite these facts, forest protection continues to remain on the sidelines of the national climate agenda and renewable energy policy in the US. Dogwood Alliance's new forest and climate program is designed to shift this dynamic, by elevating the current climate justice threats posed by biomass and building support for forest protection as a national climate justice priority. In 2018, we convened a group of 25 conservation and justice organizations, scientists and foresters from across the nation in the development of a national platform (Stand4Forests) denouncing biomass as a climate solution and calling for forest protection as a national climate and justice priority. Outreach resulted in over 200 organizations, climate scientists, elected officials and climate movement leaders such as Bill McKibben signing onto the platform. We publicly released the platform at two press conferences in Atlanta and Raleigh hosted by two state senators in North Carolina and Georgia who publicly pledged to support the introduction of state forest policy consistent with the platform. In addition, we engaged over 300 organizations in 24 cities across 12 Southern states via the Justice First Tour in partnership with New Alpha Community Development Corporation and the Sierra Club Ready for 100 campaign in an effort to build solidarity in the climate and justice movement across the South with a unified message calling for 100% clean renewable energy (no biomass), a scale up in the protection of forests and environmental justice for low-income people and communities of color. Media coverage of the Justice First tour and our work on forests and climate had a reach of over 70 million, including a radio spot on Yale Climate Connections which aired on over 400 radio stations across the country, and coverage in Huffington Post and Reuters.
