



Part 3 Organizations Primary Exempt Purpose. The Belt Volunteer Ambulance Service is a public charity formed to provide no-cost or low cost pre hospital emergency care and emergency ambulance transportation for residents of Belt and residents of Eastern Cascade County, Montana.

Part 3 Achievements: During 2018, BVAS provided medical care to over 140 patients in our service area and surrounding areas. All services were provided by volunteers. BVAS provided training sessions where members of surrounding services were invited to participate. BVAS personell attended several symposiums and training sessions throughout the State in furtherance of their EMS education. During 2018, BVAS acquired a Nitronox unit to provide non-narcotic pain relief for patients. In November, BVAS conducted EMR classes for area firefighters, Benefis Medical center employees, a Cascade County Sheriff deputy and Belt City Clerk. 14 students successfully completed the classes, passed State exam and are currently awaiting licensure.
