29 The Ad Hoc Communication Committee established in 2017 continued its work to increase awareness and recognition of the USDA McIntire-Stennis Cooperative Forest Research Program. This was one of the goals of the Strategic Plan which the membership worked on over 2015-2016 period. In 2018, the committee sought compelling examples of research being done at NAUFRP institutions and developed a template that each institution could use to highlight the impacts resulting from research funded through the McIntire-Stennis program. These issues papers are intended to be shared with a wide range of audiences and posted on the NAUFRP web page. Funding for developing a stand alone McIntire Stennis website is being explored. The NAUFRP Executive Committee worked with the USDA National Institute of Food and Agriculture to plan and organize a conference of university Agriculture Technical Representatives (ATRs) for the NIFA McIntire-Stennis Cooperative Forestry Research Program. Many NAUFRP representatives serve as the ATR for their institution. The target date and location of the meeting was March 2019 in Washington, D.C.
