given funds to several organizations each year that are not required by the governing documents and these organizations have come to rely on these funds from the trust.

The trust's governing document states that the amount required to be distributed to donee organizations each year is based on net revenues from the trust's prior year end and excludes non-cash contributions made to the trust. Year 2017 net revenues of \$2,131 (\$64,467 - less \$62,336 non cash contribution for a building the trust received) was much lower compared to net revenues from 2016 of \$78,683. This considerably decreased the trust's funds available to distribute to charitable organizations resulting in lower amounts given to the 7 organizations listed in the governing documents and several organizations from 2017 not getting any funds at all for 2018. Of course each year 30% of the support funds distributed by the trust are given at the discretion of the trustee, so those organizations receiving this funding can change yearly; therefore, several were removed and one organization was added for 2018.
