COMMUNITY ENGAGEMENT AND EDUCATION IN 2018, PARK PRIDE PRESENTED OUR 17TH ANNUAL PARKS & GREENSPACE CONFERENCE, "PARKS AND THE RESILIENT CITY" EXPLORING THE ROLES PARKS PLAY IN MITIGATING THE EFFECTS OF DISRUPTIVE EVENTS SUCH AS FLOODING AS WELL AS MORE GRADUAL CHANGES LIKE POPULATION GROWTH. OVER 500 ATTENDEES GATHERED TO HEAR FROM LEADERS WHO ARE GUIDING THE GREENSPACE CONVERSATION LOCALLY, NATIONALLY AND GLOBALLY. THROUGHOUT 2018, PARK PRIDE WORKED TO EMPOWER RESIDENTS TO PARTICIPATE IN PUBLIC DISCOURSE AND RESPOND TO EMERGING PARK ISSUES. EFFORTS INCLUDED ORGANIZING PARK ADVOCATES TO ATTEND CITY COUNCIL HEARINGS TO VOICE THEIR SUPPORT FOR AN INCREASED BUDGET FOR PARKS MAINTENANCE AND OPERATIONS, HOSTING A SPECIAL MEETING TO PROVIDE INPUT TO ATLANTA'S URBAN ECOLOGY FRAMEWORK, SERVING AS A MEMBER OF THE OUTDOOR STEWARDSHIP COALITION, AND SUCCESSFULLY ADVOCATING FOR THE PASSAGE OF THE GEORGIA OUTDOOR STEWARDSHIP ACT, LEGISLATION THAT WILL SET ASIDE UP TO \$20M PER YEAR FOR LAND CONSERVATION AND PROVIDES A SOURCE OF MATCHING FUNDING FOR LAND CONSERVATION AT THE STATE LEVEL. ADOPT THE ATLANTA BELTLINE PARK PRIDE COORDINATES THE ADOPT THE ATLANTA BELTLINE PROGRAM, PROVIDING AN OPPORTUNITY FOR COMMUNITY GROUPS, ORGANIZATIONS AND BUSINESSES TO ADOPT AND MAINTAIN -MILE SEGMENTS OF THE ATLANTA BELTLINE. IN 2018, 51 ADOPTER GROUPS PARTICIPATED IN THE PROGRAM, WITH 1152 VOLUNTEERS CONTRIBUTING 3662 VOLUNTEER HOURS OF SERVICE ON THEIR ADOPTED SEGMENTS. COMMUNITY GARDENS COMMUNITY GARDENS ARE A GREAT WAY TO BUILD RELATIONSHIPS, REVITALIZE PUBLIC SPACES, PROVIDE ACCESS TO HEALTHY, AFFORDABLE FOODS AND CREATE AN ENJOYABLE ACTIVITY FOR PEOPLE OF ALL AGES. IN 2018, PARK PRIDE PROVIDED ONGOING SUPPORT FOR 22 NEIGHBORHOOD GROUPS AND NON-PROFIT ORGANIZATIONS THAT HAVE ESTABLISHED COMMUNITY GARDENS IN CITY OF ATLANTA. PARKS THROUGH THE COMMUNITY GARDENING PROGRAM, PARK PRIDE CONNECTS GARDENERS TO LOCAL RESOURCES FOR GARDENING, AN ANNUAL TOUR OF COMMUNITY GARDENS, PROVIDING OPPORTUNITIES FOR GARDENERS TO NETWORK, SHARE IDEAS AND GAIN INSPIRATION FROM EACH OTHER. VOLUNTEER PROGRAM PARK PRIDE COORDINATES THOUSANDS OF VOLUNTEERS EACH YEAR TO HELP MAKE AESTHETIC AND FUNCTIONAL IMPROVEMENTS TO PARKS THROUGHOUT OUR SERVICE AREA. IN 2018, PARK PRIDE COORDINATED 6,732 VOLUNTEERS IN PARKS ACROSS ATLANTA AND DEKALB COUNTY. CORPORATE GROUPS, STUDENT GROUPS AND CIVIC MINDED ORGANIZATIONS MADE SIGNIFICANT IMPACTS TO PARKS BY LACING UP THEIR BOOTS AND GETTING THEIR HANDS DIRTY. THE GROUPS PROVIDED A TOTAL OF 22,573 HOURS OF VOLUNTEER SERVICE TO ACCOMPLISH A VARIETY OF PROJECTS INCLUDING INVASIVE REMOVAL, EROSION CONTROL, FOREST RESTORATION, NEW TRAIL CONSTRUCTION AND BEAUTIFICATION.
