Parkwest Medical Center ("Parkwest") admitted its first patient on December 10, 1973. It became a not-for-profit hospital in 1990 and joined the Covenant Health system in 1996. SERVICEWest Knoxville's largest medical center, Parkwest has an organizational culture focused on treating every patient and visitor with courtesy, compassion, and respect. It is best known for excellence in orthopedics, cardiology, surgical, emergency, labor and delivery, and behavioral health. Parkwest served 218,030 patients in 2018. Of these, 199,831 were outpatients and 18,199 were inpatients with an average length-of-stay of 5.25 days. Peninsula, a division of Parkwest Medical Center ("Peninsula") is the behavioral services division of Parkwest Medical Center and the region's largest provider of behavioral health services. Peninsula has a 155-bed hospital in Blount County providing mental health services for adolescents and adults. Peninsula also provides outpatient services in four counties: PUTTING PATIENTS FIRST. In 2018, Parkwest was recognized by U.S. News & World Report as a Top Ten Regional Hospital in Tennessee, and rated as a high performing hospital by U.S. News & World Report for hip and knee replacements, aortic valve replacement and treatment of abdominal aortic aneurysm. BlueCross BlueShield gave the hospital a Blue Distinction Center for Knee Replacement and Hip Surgery, Maternity Care and Spine Surgery. Parkwest's Joint Replacement Center has the second highest patient volume in the state. The Joint Commission has designated the hospital as an Advanced Primary Stroke Center, and Parkwest is a member of Covenant Health's stroke hospital network, which links Covenant Health's member hospitals in providing rapid diagnosis and treatment of stroke. The heart hospital at Parkwest has been designated by The Joint Commission as a top performer in heart, pneumonia and surgical care. Parkwest is participating in a national initiative related to improving survival rates and outcomes for patients experiencing cardiogenic shock, and has earned the Silver Plus Quality Award from The American Heart Association, recognizing consistent compliance with evidence-based quality measures for care of patients experiencing heart attacks. The East Tennessee Breastfeeding Coalition presented the hospital with the Marcie Singleton Award for promotion and support of breastfeeding. Parkwest consistently receives excellent safety and customer satisfaction ratings from multiple survey sources: IMPROVING THE COMMUNITY'S QUALITY OF LIFE THROUGH BETTER HEALTH. The Tennessee Association of Mental Health recognized Peninsula's transitional task force as a program of excellence, and in 2018 Peninsula helped create the area's first suicide support group formed for those who have lost a loved one to suicide. Parkwest provided over \$10,000 worth of taxi/transportation vouchers to patients who were discharged and had no transportation available. Employees participate in the Greater Knoxville Heart Walk, raising funds and awareness for heart disease, and the March of Dimes March for Babies, which focuses on improving the health of newborns and infants. Parkwest also participates in local health fairs, screenings for area businesses and groups, usually providing carotid ultrasound screenings and physical therapy ergonomic education, as well as stroke education. The hospital has developed an "Honor Walk," a recognition of patients who have chosen to be organ donors in the event of their death. When this occurs, staff members gather in the hallways to pay final tribute as the patient is taken to the operating room for the organ donation procedure. COVENANT HEALTH SYSTEM. Parkwest is a member of Covenant Health. Covenant Health is a comprehensive, community-owned health system dedicated to improving the health of the people it serves. Established in 1996 by the consolidation of Fort Sanders Health System, Knoxville, Tennessee, and MMC HealthCare System in Oak Ridge, Covenant Health is governed by a voluntary board of directors comprised of community leaders and medical professionals. With more than 10,000 employees, affiliated physicians and volunteers, Covenant Health is the Knoxville area's largest employer and has been named by Forbes as a Best Employer four years in a row. Covenant Health includes nine acute care hospitals in East Tennessee: Methodist Medical Center of Oak Ridge, Fort Sanders Regional Medical Center and Parkwest Medical Center in Knoxville, Fort Loudoun Medical Center in Lenoir City, LeConte Medical Center in Sevierville, Morristown-Hamblen Healthcare System in Morristown, Roane Medical Center in Harriman, Claiborne Medical Center in Tazewell and Cumberland Medical Center in Crossville. It also includes Peninsula, a division of Parkwest Medical Center, a behavioral health hospital in Blount County, Tennessee. Affiliated organizations include Thompson Cancer Survival Center, Thompson Oncology Group, Fortress Corporation and Subsidiaries, Covenant HomeCare, and Fort Sanders Perinatal Center. Philanthropic organizations include Fort Sanders Foundation and the Thompson Cancer Survival Center Foundation in Knoxville, Methodist Medical Center Foundation in Oak Ridge, Dr. Robert F. Thomas Foundation in Sevierville, and Morristown-Hamblen Hospital Foundation in Morristown. Funds raised by the foundations provide services, equipment and other resources for excellence in patient care. Parkwest, as a member of the Covenant Health system, benefits from the collaboration among all affiliated organizations to promote quality improvement, patient safety and efficient delivery of care for the communities served.

Parkwest will not engage in extraordinary collection actions ("ECA") before it makes reasonable efforts to determine whether an individual who has an unpaid bill is eligible for financial assistance. Reasonable efforts to determine whether the individual who has an unpaid bill is eligible for financial assistance include notification to the individual of the FAP, contacting individuals who have submitted incomplete financial assistance applications regarding how to complete the application and allowing a reasonable time period to do so, and reviewing completed applications for financial assistance eligibility. Parkwest does not sell any accounts receivable accounts to outside firms. All accounts remain property of and under the policies set by Parkwest. According to the policy, the financial counselors initiate screening of the patient and/or guarantor by obtaining income and other financial information to determine eligibility for charity care or discounted services. Inpatient and observation patients without insurance receive a packet of information from the case managers on the nursing units. This packet includes a Financial Assistance Application, "How to Apply for TennCare and instructions on the Healthcare Exchange. TennCare applications are made online or by phone through the Healthcare Exchange process. Also included in the packet is how to apply for the Qualified Medicare Beneficiary program.
Part VI, Line 4	Parkwest is located in the west area of Knoxville, Tennessee. Although located in metropolitan Knox County, Parkwest receives many specialty referrals from outlying hospitals and physicians and serves patients from 16 diverse counties, a mix of urban, suburban and rural. According to internal hospital data for 2018, more than 57% of the inpatient and outpatient cases came from Knox County residents. Parkwest also provides mental health services to the region through its behavioral health division, Peninsula. Peninsula is East Tennessee's leading provider of behavioral healthcare services. Peninsula offers a complete range of mental health and alcohol/drug treatment programs. In addition to outpatient centers in Blount, Knox, Loudon and Sevier counties, care is also offered at Peninsula, a 155-bed inpatient facility which serves more than 5,000 patients annually. The percent of the population that is 65 years or older constitute 15.2% of the residents. The unemployment rate in 2018 was 4.1%. Parkwest operates a 462-bed acute care hospital in Knoxville, Tennessee, and provides a full range of inpatient and outpatient hospital services. It has been named as one of the nation's top 100 cardiovascular hospitals seven times of the award's eight-year history and offers a full cardiovascular service line that includes coronary bypass surgery, diagnostic and interventional cardiac procedures. Patients may also receive treatment in one of Parkwest's specialty centers, which include: - The Senior Behavioral Center, a 16-bed unit for older psychiatric patients - A Bariatric Surgery Center of Excellence - A Joint Replacement Center A surgical center utilizing the BrainSUITE system for brain, spine, ear, nose and throat surgery. Parkwest also owns and operates Peninsula, a 155-bed psychiatric hospital located in Louisville, Tennessee. Peninsula has outpatient centers in Knox, Blount, Sevier and Loudon Counties. Peninsula is a valuable resource providing support for emergency rooms at the system's seven acute care hospitals. The affiliation makes for an accessible and efficient pathway for patients who require mental health services post-discharge. Parkwest and Peninsula patients benefit from the availability and ease of access to Covenant Health affiliated entities for services not provided by the hospitals themselves. Transfer or referral to such services is expedited and coordinated to help create a seamless continuum of care. Specialized services such as inpatient rehabilitation, cancer treatment, home health and hospice services are provided by affiliated entities. The Covenant Health system also enhances the patient's access to care through the provision of outpatient services in a variety of settings located throughout the service area. These include diabetes, wound care, and ambulatory infusion centers. The Fort Sanders Foundation seeks out community financial support for Parkwest and Peninsula. Funds are used for indigent patient care, medical equipment, outreach programs, services and staff. Through this combination of resources and the collective development, implementation and monitoring of clinical protocols and other improvement initiatives, the affiliated entities of Covenant Health are able to deliver higher quality care in a more efficient manner than could be achieved working independently.

This program ensures that clients receive comprehensive case management, care coordination, health promotion, patient and family care support and referrals to additional support as needed. In 2018, Peninsula served 1,423 clients - Women in Treatment - provides comprehensive treatment to uninsured women aged 18-64 who are currently battling addiction. Forty-five women were served in 2018 - KARM Partnership - Peninsula employs a staff member to serve as a liaison between the hospital inpatients and the Knoxville Area Rescue Mission. Total cost of care to facility is \$12,600-\$15,750 per year. Decrease Opioid Abuse- Peninsula no longer prescribes opioids in its outpatient clinics. Decrease Tobacco Use Among Youth and Pregnant Women- Peninsula Peer Support Program in Blount, Knox and Sevier Counties all offer smoking cessation classes using a curriculum approved by the State of Tennessee. Increase Access to Safe Greenways, Sidewalks and Parks- Parkwest is a major sponsor of the annual Covenant Health Knoxville Marathon. In 2018, the Covenant Health Knoxville Marathon had 8,327 participants in the various events including a Kids Run, 5K, Relay Teams and half and full marathons. This was the 14th year of supporting the marathon at a cost of nearly \$80,000. At the end of the event each year \$15,000 - 18,000 is given back to the community from the event proceeds to support additional greenways, walking trails and programs that promote physical activity - Dogwood Patch Program - The third annual Dogwood Patch program was held in 2018 in collaboration with the Dogwood Arts organization. Residents who walk 25 miles or more of Dogwood Trails during a two month period earn an embroidered patch. A new patch is designed each year. In 2018, 141 residents participated - Covenant Health Biggest Winner Program - a twice a year program for employees to focus on weight loss and improving their personal health biometrics. Local trails are used for the exercise component. The program culminates in the participants finishing their program by participating in either the 5K run/walk of the Covenant Health Knoxville Marathon or the Subway Race for Cancer 5K run/walk. In 2018, 17 employees participated in the Biggest Winner Program.

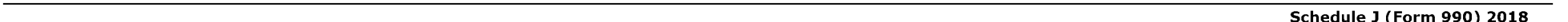

The bylaws were also amended to authorize the board to establish special board committees which may be terminated by resolution of the board. The chairman of the board may establish special board committees to advise executive leadership, other board committees or the full board. Committees may be composed of elected or ex-officio board members. Also in 2018, Covenant Health adopted system-wide medical staff bylaws. The bylaws created two new committees: System Quality Committee and System Credentials and Clinical Standard Committee. The System Quality Committee consists of licensed physician voting board members, other appointed voting board members, Covenant Health's CEO, and the chiefs of staff of Covenant Health system hospitals. The committee shall review quality of patient care, perform other duties assigned in the system-wide medical staff documents, receive and review proposed amendments to the medical staff documents and make recommendations to the board, initiate quality-related investigations, and act as a Quality Improvement Committee as defined under Tennessee law. The System Credentials and Clinical Standard Committee consists of licensed physician voting board members and other appointed board members. Covenant Health's VP of Hospital Operations, Chief Medical Officer, and Chief Nursing Officer shall also serve as non-voting members of the committee. The committee shall develop and implement system-wide clinical standards, perform other duties as outlined in the medical staff documents, make determinations regarding routine credentialing matters and medical staff appointments/terminations, and act as a Quality Improvement Committee as defined under Tennessee law. Other 2018 amendments to the governing documents were not considered significant.

When appropriate, these bodies may also consult legal counsel. Restrictions imposed on persons with a conflict of interest are determined on a case by case basis. For Covenant Health employees, the Chief Compliance Officer in conjunction with Covenant Health Executive Leadership determines how to appropriately manage the conflict. In any conflict involving a board member, such member is expected to recuse himself or herself from voting on matters related to the conflict.
