GraceWorks hosted 68 church/school groups here in Alaska in 2018. 1145 volunteers plus about 40 volunteer staff. We worked in 11 local parks five days a week all summer long. We shared the God's love and the Gospel through our actions and through our words. We served almost 14,000 meals to disadvantaged children in the local parks here. We hosted about 80 community park parties complete with bounce house and free food served. Other projects included our Iditarod mission, a Spring Break project, two Native village projects, and two work team projects.

Overseas. We took an evangelism team to Romania & Ukraine. Expenses include plane tickets, insurance, ground costs (food, housing, transportation). Also included here is 5% of Scott Kirby salary package since he organized and led these teams. Also we made gifts of \$18,871 total to Romanian & Ukrainian church workers.
