Housing Programs Eden Village is the largest housing program for women in Atlanta and serves more than 600 clients annually. In 2018, Eden Village provided housing to 114 mothers, 242 children and 284 single ladies without children for a total of 640 residents. One hundred and fifteen Eden Village adult residents attained employment in 2018. House of Cherith is an emergency and long-term residential trauma-informed care program for rescued survivors of sexual exploitation and trafficking, with a focus on recovery and restoration. In 2018 House of Cherith housed 162 women and provided food, nutrition, counseling, case management, substance abuse treatment and vocational training. They achieved healing and life success.

Form 990, Part III, Line 4b:

Health and Wellness Through our 180 Kitchen and our on-site partnership with Mercy Care, COR provides residents with nutritious meals 3 times a day, 365 days a year, and access to general medical, dental, vision, and mental health services. The kitchen provides more than 300,000 healthy meals per year to resident families and children attending on-site programs. Clothing, rent and utility assistance, and transportation assistance are also provided.

Form 990, Part III, Line 4c:

Vocational The year 2018 was a banner year for the Workforce Innovation Hub. The Workforce Innovation Hub has placed 365 women and men in jobs through workforce development, graduated 233 students and placed 166 of those students in jobs. The Workforce Innovation Hub has held 7 Customer Service Sessions for 65 students, 12 Security Academy Sessions for 106 students, three 180 Degree Culinary Training sessions for 26 students and two NAPA Auto Center sessions for 30 students. Each job training track has a different job placement rate that averages to 71%. The NAPA and 180 Degree programs have close to a 100% placement rate and the Workforce Innovation Hub staff is utilizing those programs as a model to improve the job placement rate in the other programs.
