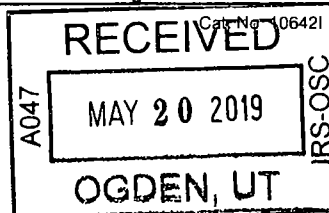



The sole liability in 2017 was 2018 dues collected in advance of December 31 There were no such prepayment of dues at the end of 2018

Part III Primary Purpose

The Objects of the SAR are declared to be patriotic, historical and educational, to unite and promote fellowship among the descendants of those who sacrificed to achieve the independence of the American people, to inspire them and the community at large with a more profound reverence for the principles of the government founded by our forefathers, to foster true patriotism, to maintain and extend the institutions of American freedom The Florida SAR fulfils it Mission through its Youth Programs, it state and chapter publications, its state and chapter Color Guard activities, presenting commendation awards to Law Enforcement, Firefighter and EMS personnel and other public outreach activities

Part IV Line 49a Transfer to Related Non-Profit Organization

In accordance with the Standing Rules of the Florida SAR, the organization makes a single annual payment to the principal of the FLSSAR Endowment Trust Fund, a related but separately governed non-profit organization This grant represents \$1 00 per active member as of January 1 of the current year (\$2,058 in 2018) The Endowment Trust Fund uses its investment income (only) to fund certain approved activities of the local chapters of the Florida SAR
