Provides emergency food relief to the hungry in North Brevard. Food given out is nutritionally balanced for the individual or family receiving assistance. Personal hygiene products are provided when available. Normal assistance is provided every three months with extra assistance at Easter, Thanksgiving and Christmas. The facility is normally open three days a week. There is never a charge for any products or services provided.

The fundamental purpose of the organization is helping the needy of North Brevard. Providing food is top priority of the organization. Cor Jesu collects, purchases, sorts, packages and distributes food to the needy at its facility located on South Hopkins Avenue in Titusville. In 2018, 1,713 households consisting of 3,586 individuals received food assistance. Most of the food consisted of non-perishable canned and boxed items. We also regularly receive from a couple of local grocery stores large amounts of food, including fresh fruits and vegetables, bread, bakery items, meats/fish and assorted non-perishable products. Additional meats, when needed, were purchased from the local food bank. Eggs and butter are obtained locally. Perishable food is stored in refrigerators and freezers until distributed. Hygiene products are also provided when available. Volunteers pickup and collect food, others sort and stock the shelves, while others register new clients and assemble the bags that are given away. Each client receives several bags of food. All of our funds are used to purchase food, except for small amounts for utilities and to maintain the building.

Eggs and butter are purchased locally to add to the assortment. Most donated items are boxed or canned. We have several refrigerators and
freezers to store perishable items. Our inventory turns over very quickly
