ATTACHED IS A COPY OF THE UNANIMOUS WRITTEN CONSENT OF THE DIRECTORS OF THE KDK-HARMAN FOUNDATION APPROVING THE PLAN OF TERMINATION.

AS REPORTED ON THE FOUNDATION'S 2017 FORM 990-PF, DISSOLUTION WAS EXPECTED TO OCCUR IN 2018. HOWEVER, THE FOUNDATION RECEIVED RECOVERY PROCEEDS FROM THE BERNARD L.
