In addition experienced staff is available for response to current issues and support to our members. The "main" office houses the "Wee Care" program that supplies and goods for infants to over 600 families every year as they are referred to us by state social workers, Christian service agencies, and individuals. Our chapter offices also maintain space needed to operate our youth program which reaches the tri-county area.

Meeting space is available to other pro-life groups.
