STUDENTS PARTICIPATING IN PROGRAMMING ARE REFERRED THROUGH THE PRINCIPALS AND GUIDANCE COUNSELORS OF THE SCHOOLS SERVED. THESE ARE CHILDREN WHO ARE STRUGGLING EITHER SOCIALLY OR ACADEMICALLY AND NEED EXTRA SUPPORT. PROGRAM DIRECTOR MAKES SCHOOL VISITS TO MONITOR THE PARTICIPANT'S PROGRESS & SPENDS TIME SUPPORTING THE STUDENTS IN THE SCHOOLS. DURING THE SUMMER, THE CHILDREN ATTEND AN 8 WEEK ACADEMIC-BASED PROGRAM.
