Cancer and Palliative Care The Foundation's cancer patient fund provides emergency assistance to patients undergoing cancer treatment at Morristown Regional Cancer Center. Funds provide assistance for transportation, food and basic living needs, and specialized skin creams to aid in healing for radiation patients. The 2018 assistance provided included gas cards for transportation to treatment, groceries, medications and radiation skin cream, utilities, and dental care. Staff Education Distributions from the Foundation's staff education fund provided membership for 27 imaging department staff members to the American Society of Radiologic Technologists. Membership includes continuing education opportunities/certifications and CEU tracking, as well as access to research and education materials.

Tomosynthesis Morristown-Hamblen Hospital Foundation provided a \$200,000 matching grant to Morristown-Hamblen Hospital Association dba Morristown-Hamblen Healthcare System ("Morristown-Hamblen") for the purchase of high-resolution, 3D, digital mammography screening technology called tomosynthesis. Conventional mammography produces one image of overlapping tissue, which can make it difficult to detect cancers. Tomosynthesis takes multiple images of the entire breast, improving the image quality for clinicians, while at the same time decreasing the radiation dose received by patients. Using tomosynthesis, radiologists can see through layers of tissue and examine areas of concern from all angles. Studies show this advanced technology finds 41% more invasive breast cancers than traditional mammography by imaging the breast in "slices" to find even the smallest developing tumors. Screenings with tomosynthesis also result in up to a 40% decrease in the need for patients to return for additional imaging due to "false positives" which greatly reduces patient anxiety. Clinical benefits of tomosynthesis can include earlier detection of small breast cancers that may be hidden during traditional mammography, greater accuracy in pinpointing size, shape and location of abnormalities, fewer unnecessary biopsies or additional tests, greater likelihood of detecting multiple breast tumors, and clearer images of dense breast tissue.

Form 990, Part III, Line 4b:

Speech Therapy Proceeds from the Foundation's 2018 Classy County Gala and Auction provided for the purchase of specialized equipment used by the hospital's speech therapists. The Fiberoptic Endoscopic Evaluation of Swallowing (FEES) equipment provides a patient-focused swallowing evaluation that is the preferred method over the traditional modified barium swallow (MBSS). FEES is portable, so it can be used at the patient's bedside, with outpatients, and with patients in isolation, as well as providing better care to patients with limited mobility and special needs. It uses a small camera inserted through the nose and can provide greater sensitivity than traditional tests. FEES also allows the assessment to be done with the foods the patient would normally eat, without barium, which means no radiation exposure to the patient. Using FEES, the speech therapist can determine if fatigue is an issue because the evaluation can be performed throughout an entire meal, providing information on both swallow function and voice mechanism function.

Morristown-Hamblen Patient and Employee Emergency Assistance Contributions from the annual employee giving campaign support the assistance fund at Morristown-Hamblen, which provide emergency assistance for patients and employees in times of crisis. In 2018, the funds assisted 19 employees and 33 patients with emergency aid for items such as housing, utilities, transportation, medications, medical equipment and funeral expenses.

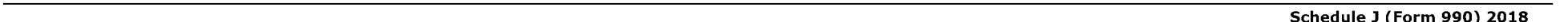
