Equip believers internationally - 10/40 Connections provides relevant and practical theological instruction which impacts the whole person and the whole community. Our Ummeed project developed 1,400 leaders through 36 seminars in multiple states of India. With 16 classes and 8 teachers, our literacy programs helped 175 people learn to read and write. For those who want to understand more about how to have a clean heart, and not just do good deeds, we are happy to share some good news. While most religions attempt to help people become better people or please God, we have found that Jesus Christ actually makes it possible. After he lived a perfect life without one wrong word, deed, thought, or motive, Jesus allowed himself to die on the cross to pay the penalty for the wrong things people do. Three days later the resurrection of Jesus showed that he had power over death, and that people need not live in fear. Jesus offers forgiveness and a clean heart to anyone who would call on his name and live their lives up to his. If you have questions, we are happy to discuss this further.

Empower at-risk children - 10/40 Connections works to provide whole-life change, hope and protection to at-risk children through expanding their educational opportunities. We sustained 23 schools in slum areas which educated and fed 690 children. We completed the construction of a new school that educates 500 students daily. We started a new school in a village that previously had zero access to education, now 25 children study daily. We funded educational expenses for 20 girls rescued from abusive situations.

Fight injustice - 10/40 Connections battles the global epidemic of human trafficking through setting up surveillance stations and recovery homes in Nepal. We also address the lack of health education for women by offering our Voice for the Voiceless curriculum. In 2018 we completed the construction of the Crown of Beauty Maternity Home which provides help and services to at-risk mothers and their pre-born babies. We also completed the construction of a safe home for women rescued from trafficking. In 2018, our programs helped 7 pregnant women and their 7 babies, and over 3,000 participants in Voice for the Voiceless seminars.
