As a board member they attend monthly meetings, assist during the campaign and the funds distribution process, serve as ambassadors for the organization and help secure other volunteers, supporters and donors. Funds distribution volunteers are assigned to one of four agency focus areas, Helping Youth Succeed, Meeting Basic Needs, Serving People with Special Needs, and Strengthening Families and Individuals.
