The Shirley & Leonard Goldstein Supporting Foundation supported activities for the benefit of the Jewish Federation of Omaha, Inc. including funding for its agencies to provide to the Jewish community such things as scholarships, financial assistance to those in need and educational and cultural programs.

Grants totaling \$7,048 were awarded to Chabad Lubavitch of Nebraska to support their summer camp and their Chessed program which helps feed the hungry, provide clothing, furniture, companionship, emergency relief, rent subsidies, medical support, elderly counseling, transportation and holiday gatherings for immigrants.

A grant of \$5,000 was awarded to the Wurtman Foundation for Emergency Aid to former Refuseniks (Soviet Jews who were discriminated against and refused permission to emigrate) who continue to struggle financially.
