The Board members review the reports, comment and discuss with th Executive Director, accountant and legal team. Board minutes are signed and written up by the Secreatry.

They reviewed the document and a final version for approval and signature was sent again before the delivery of the form.

Part VI, Line 15a. At the end of the 2017 year a part time consultant was hired to manage the active grants. However by the first quarter of the 2018 year, the Board approved the hiring of another part time consultant to work with the internal bookkeeping of the grants and donations, and a project manager for our biggest project. Decisions were made based on knowledge, flexible time, availability and trust of the two additional consultants that were hired part time. By the end of the third quarter the Board decided that it would be best for the sustainability of the organization to hire a consultant that could serve as an Executive Director until 2019, when relief work was expected to evolve.
