We have five major programs: (1) Bee Patches pollinator habitat education and planting with youth; (2) rain catchers water conservation program; (3) worm wizards vermiculture composting program; (4) cultivating commerce supporting local agricultural entrepreneurs; and (5) fire resiliency support.
