This included helping individuals find the best agency to fit their needs. The Organization is partnered with many local agencies including but not limited to Volunteers of America, Alta California Regional Center, Turning Point and County of Sacramento Adult Protective Service. We also assisted in medicine management by delivering medicines at appropriate times, ensuring residents were making it to programs provided by their agencies as well as making it to their scheduled doctor appointments.</p>
