Energy Efficiency Programs: Conducted door-to-door outreach signing residents up for free energy audits, recycling, trees and other resources. We completed about 300 home energy audits in Denver. Low-cost and major energy upgrades, such as insulation or energy efficient appliances, were installed in many of these homes.

Green Team Youth Employment Program: GWD employed 71 youth who worked in urban gardens and on neighborhood improvement and civic engagement projects related to environmental issues as well as healthy eating and active living. Ages ranged from 13 to 24. The older youth (age 18-24) worked at the Rocky Mountain Arsenal National Wildlife Refuge and on other public lands. The youth age 14-17 worked on community projects including urban farming and water quality. The youngest students (age 13-14) worked on a variety of projects mentored by the older youth.
