

During that time, she embezzled over \$200,000 from the League. When the Board discovered what she was doing, she was removed from the Board and the police were contacted. Before charges could be filed, Ms. Salles committed suicide. The amount shown is what she stole in 2018.

The actions of Ms. Salles left the League with no funds and outstanding debts. To continue to operate, the League took out two loans.

The first loan in the amount of \$5,070 was from Board Member, Miles Bingham. This no interest loan was repaid in full during 2018.

The second loan in the amount of \$20,000 was from First American Bank and Trust. This loan is being paid back over a 2 year period. The outstanding balance of this loan on December 31, 2018 was \$14,927. This is included as a Liability.

The League had three outstanding checks at the end of 2018. Checks 2112 and 2113, each for \$150 were to coaches for the Winter Camp.

The third check, 2015 is to the Louisiana Soccer Association (LSA) as a \$500 Bond for teams playing in their League.

The result is a negative change of \$972.02 (20,000+5,070-10,316-14,927-150-150-500)
