• The New Orleans International Human Rights Film Fest received 31,060.49 and continued in exhibiting/distributing documentary films.

• Other films and projects received 1,365.79 and continued in production

Other projects did not receive direct financial support in 2018, but continued to receive technical assistance, advisory services, and other
production support from Video Veracity, Inc. as production and distribution continued. They include:

• Art Index, a PBS television series on contemporary visual art and sculpture, continued in distribution.

• Welmon, a film on a long-time eccentric Louisiana folk artist

• Allen Toussaint: The Songwriter Tapes, a documentary on songwriter/producer Toussaint, filmed from 1980-2004

• Give Light, a film on midwives worldwide

• Bayou Maharajah, a film on legendary New Orleans genius piano player and teacher James Booker
