The church has 200 regular attendants and serves many hundreds more in the area; Our direct outreach involvement includes funding a children's ministry serving 110, a Spanish ministry, supporting neighboring elementary schools, a homeless ministry and other programs; (2) support of the Oklahoma Assemblies of God oversight organization in its mission of providing resources and assistance to approximately 2000 Assemblies of God ministers and 475 churches in Oklahoma; (3) providing support to a ministry that distributes household goods to families in need; (4) supporting other national ministries that spread the Gospel of Jesus Christ to the U.S.

Provided funds to assist with ministry endeavors in foreign lands, including:
 (1) construction of 4 Assemblies of God (A/G) church "tabernacles" in Madagascar and two in Ghana. Each of these steel structures can accommodate 350 congregants. (2) remodeling the Springfield, MO headquarters of Africa Tabernacle Evangelism and several other ministries serving the 50+ countries of Africa with more than 77,000 A/G churches and 17 million believers; (3) Monthly support for five A/G missionary families living and ministering overseas in Africa, Mexico & Ireland; (4) provided literature for a new children's program for Madagascar A/G churches serving more than 100 boys and girls; (5) support for various other ministries involved in reaching people for Christ around the world.

Provided funds for the support of religious higher education, including:
 (1) Funding for Malawi Assemblies of God (A/G) School of Theology ongoing construction, maintenance, & student scholarships in Lilongwe, Malawi. These will pastor and do church work throughout Africa; (2) Funding to write another college-level Bible course that will be used in 900 Spanish A/G Bible Schools in Latin America and to help train 3 million house pastors in Northern Asia. This one is called "Leadership 2". (3) Purchasing land/buildings for a Bible School in Songa Burundi that will train 25 students per term.
