In 2018, included in the many projects we worked on, EMI USA designed electrical upgrades at hospitals in ministry centers in Gabon, Tanzania, and Zambia; EMI USA worked on hospitals in Kenya, Angola, India, and Malawi; and EMI USA assisted after earthquakes and

AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
ENGINEERING MINISTRIES INTERNATIONAL USA

ARTICLE I

NAME

The name of the corporation is Engineering Ministries International USA (hereinafter referred to as "EMI USA")

ARTICLE II

DURATION

The duration of EMI USA is perpetual.

ARTICLE III

MEMBERSHIP

EMI USA shall have no voting or non-voting members.

ARTICLE IV

PURPOSES AND POWERS

Section 4.1 Purposes. EMI USA is organized and shall be operated exclusively as a Christian non-profit organization for religious, educational and charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding statute thereto. Subject to the foregoing, the specific purposes of EMI USA shall

include but not be limited to developing people, designing structures, and constructing facilities which serve communities and the Church. EMI USA will do this by:

- a. Working within the local context to design and construct culturally appropriate facilities that are sustainable, affordable, and transformational.
- b. Developing people spiritually and professionally through intentional discipleship and mentoring.
- c. Building the church by connecting people of diverse backgrounds, abilities and ethnicities to demonstrate our love for God, our love for the nations and the unity we share in Christ.
- d. Mobilizing professionals to provide technical design assistance for those in need.
- e. Collaborating with, supporting, and encouraging other organizations operated for similar purposes.

Section 4.2 Powers. In furtherance of the foregoing purposes and objectives (but not otherwise) and subject to the restrictions set forth in Section 4.3, EMI USA shall have and may exercise all of the powers now or hereafter conferred upon nonprofit corporations organized under the laws of Colorado and may do everything necessary or convenient for the accomplishment of any of the corporate purposes, either alone or in connection with other organizations, entities or individuals, and either as principal or agent, subject to such limitations as are or may be prescribed by law.

Section 4.3 Restrictions On Powers.

(a) No part of the net earnings of EMI USA shall inure to the benefit of or be distributable to any director or officer of EMI USA or any other individual (except that reasonable compensation may be paid for services rendered to or for the benefit of EMI USA affecting one or more of its purposes), and no director or officer of EMI USA or any other individual shall be entitled to share in any distribution of any of the corporate assets on dissolution of EMI USA or otherwise.

(b) Upon dissolution of EMI USA, all of EMI USA's assets remaining after payment of or provision for all of its liabilities shall be paid over or transferred to

and among one or more exempt organizations described in section 501(c)(3) of the Internal Revenue Code, contributions to which are deductible under section 170 of the Internal Revenue Code. The organizations to receive such property, and their respective shares and interests, shall be designated by the Board of Directors.

(c) Notwithstanding any other provision of these articles of incorporation, EMI USA shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax as an organization described in section 501(c)(3) of the Internal Revenue Code, or by a corporation, contributions to which are deductible under section 170 of the Internal Revenue Code.

ARTICLE V

FAITH BASED ORGANIZATION

EMI USA is a faith-based organization that subscribes to the following Statement of Faith:

- (1) We believe the Bible to be the inspired and only authoritative Word of God. (II Timothy 3:16)
- (2) We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit. (I John 5:6-8)
- (3) We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood. We believe in His bodily resurrection, in His ascension to the right hand of the Father, and in His imminent and personal return in power and glory. (John 3:16; I Corinthians 15:3-4; I Peter 2:18-24)
- (4) We believe the Holy Spirit is a gift from God as promised by the Lord Jesus Christ to those who believe. The Holy Spirit brings about the conviction of sin and the new birth, bears witness of our adoption, and is the power behind Christian growth and ministry. (Matthew 3:11; John 14:16-17; John 16:5-15; Acts 1:8; Acts 2:4, 38-39; Acts 19:1-7; I Corinthians 12:7-11)
- (5) We believe that all people are lost and guilty of sin. Jesus Christ is the only mediator between God and people. Salvation is brought about, not by

works, but by faith in the work of Jesus Christ on the cross as a sacrifice for the sins of the world. (Romans 3:21-30; Galatians 4:4-7; Ephesians 2:8-9; I Thessalonians 4:13-18; Revelation 22:20)

- (6) We believe in the resurrection of everyone, both the saved and the lost; the saved unto the resurrection of life; and the lost unto the resurrection of damnation. (John 5:24, 28, 29)
- (7) We believe the Church is at the very center of God's cosmic purpose and represents the Body of Christ on earth (Matthew 28:19,20; Acts 1:8; Ephesians 3:9-11; I Corinthians 12:27)

ARTICLE VI

OFFICES

Section 6.1 Principal Office. The address of the principal office of EMI USA is 130 East Kiowa Street, Colorado Springs, CO 80903.

Section 6.2 Registered Office and Agent. The street address of the registered office of EMI USA is 130 East Kiowa Street, Colorado Springs, CO 80903. The name of EMI USA's registered agent at the registered office is Mr. John Dallmann.

ARTICLE VII

BOARD OF DIRECTORS

Section 7.1 General. The management of the affairs of EMI USA shall be vested in a Board of Directors, except as otherwise provided in the Colorado Revised Nonprofit Corporation Act, these Articles of Incorporation or the Bylaws of EMI USA. The number of directors, their classifications, if any, their terms of office and the manner of their election or appointment shall be as provided from time to time in the Bylaws of EMI USA.

Section 7.2 Liability of Directors. No director shall be personally liable to EMI USA for monetary damages for any breach of fiduciary duty as a director, except that the foregoing shall not eliminate or limit such director's liability to EMI USA for monetary damages for the following: (1) any breach of such director's duty of loyalty to EMI USA, (2) any of such director's

acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (3) acts specified in C.R.S. Section 7-128-501(2), as it now exists or hereafter may be amended (regarding a director's assent to or participation in the making of any loan by EMI USA to any director or officer of EMI USA), (4) acts specified in C.R.S. 7-128-403, as it now exists or hereafter may be amended (regarding a director's assent to or participation in unlawful distributions), or (5) any transaction from which such director derived an improper personal benefit. If the Colorado Revised Nonprofit Corporation Act hereafter is amended to authorize the further elimination or limitation of the liability of directors of corporations, then the liability of a director of EMI USA, in addition to the limitation on personal liability provided herein, shall be further eliminated or limited to the fullest extent permitted by the Colorado Revised Nonprofit Corporation Act. Any repeal or modification of this Section 7.2 shall be prospective only and shall not adversely affect any right or protection of a director of EMI USA existing at the time of such repeal or modification.

ARTICLE VIII

BYLAWS

The Bylaws of EMI USA shall be as adopted by the Board of Directors. The Board of Directors shall have power to alter, amend or repeal the bylaws from time to time in force and adopt new bylaws. The Bylaws of EMI USA may contain any provisions for the managing and regulating of the affairs of EMI USA that are not inconsistent with law or these Articles of Incorporation, as these articles may from time to time be amended. However, no bylaw shall have the effect of giving any director or officer of EMI USA or any other individual any proprietary interest in EMI USA's property, whether during the term of EMI USA's existence or as an incident to its dissolution.

ARTICLE IX
AMENDMENTS

Section 9.1 General. Except as set forth in Section 9.2, the Board of Directors shall have the exclusive power and authority at any time and from time to time to amend these Articles of Incorporation by the vote of a two-thirds majority of the directors then in office at a duly constituted meeting of the Board of Directors or pursuant to authorized action without a meeting.

Section 9.2 Exception. Article V of these Articles of Incorporation shall only be amended by a unanimous vote of the directors then in office at a duly constituted meeting of the Board of Directors or pursuant to authorized action without a meeting.
