report our United States of America activities separate from our worldwide affiliated organizations services. In other words, we will no longer
consolidate our reporting as in previous years. Unless where applicable, we will no longer mingle resources with pour affiliates overseas as
be seen, this has resulted in big differences in the figures reported in last year's report.

Parts VII, IX, are equally affected as in Part X above.
