

1 Briefly describe the organization's mission: MANNA Worldwide exists to rescue children from the grip of poverty by addressing the nutritional, educational, and spiritual needs of the children and their families. Fulfilling these objectives will enable the affected communities to develop toward a more complete way of life.

4a (Code:) (Expenses \$ 2,992,334 including grants of \$) (Revenue \$) Child Development Centers - MANNA Worldwide operates 203 projects in 49 countries throughout the world. These centers seek to provide nutritious meals, educational opportunities, medical care, and clean water according to the needs of the local community. The long term goal of these programs is to make a significant impact on the lives of the children they serve in an effort to break the cycle of poverty and cultivate thriving communities.

4b (Code:) (Expenses \$ 1,451,046 including grants of \$) (Revenue \$) Volunteer Ministry / Humanitarian Trips - Each year MANNA Worldwide provides the opportunity for several hundred people to participate in compassion / relief trips to experience firsthand the difference being made in the lives of those served by MANNA Worldwide program services. In 2018, MANNA hosted approximately 73 trips with a combined total of over 1,188 volunteer team members who served alongside the MANNA project to provide medical clinics, drill water wells, build construction projects, and conduct outreach programs for the families in the surrounding communities. Trip participants play an integral role in the effort to establish long term development in the regions where MANNA is actively engaged.

4c (Code:) (Expenses \$ 1,234,874 including grants of \$) (Revenue \$) Public Awareness and Education - MANNA Worldwide relies on a dedicated team of self-funded representatives to increase public awareness regarding the plight of children, both in the U.S. and around the world, who live in poverty. These directors conduct meetings with faith-based, civic and business organizations in communities to introduce them to opportunities to be involved in the fight against economic, nutritional, medical, and spiritual poverty. This team of directors are also responsible for the oversight of MANNA Worldwide projects within their respective regions, accountability for the funds provided for program services, and the development of new projects.

As of December 31, 2018, the Organization has no uncertain tax that qualify for either recognition or disclosure in the consolidated financial statements and does not expect this to change in the next twelve months. The 2015 through 2018 tax years remain subject to examination by the Internal Revenue Service.
