**Reasonable Cause Explanation for Omission of Schedule B**

Regarding the omission to include Schedule B with the return originally filed on November 15, 2019, reasonable cause exists for such omission. All of the Foundation's activities are performed by volunteers, including preparation of its annual tax return. That return has been prepared for many years by its unpaid President, who is not a CPA or professional tax-return preparer. In drafting the 2018 Form 990-PF, that preparer reviewed the returns filed for several past years and attempted to be careful to include all information and schedules included in those prior returns. Because no Schedule B was required or included on those prior returns, the preparer assumed that none was required for 2018. Additionally, as to the one new substantial contributor for 2018, the preparer believed that his attachment and addition to Part VII-A, Line 10 disclosing the name and address of the one new contributor satisfied all filing requirements regarding that individual, who is the same new individual contributor now listed on the enclosed, completed Schedule B.

Thus, the Foundation's omission to include Schedule B originally was due to its reasonable, good-faith reliance on past years' returns and its belief that its disclosures regarding Part VII-A, Line 10 on substantial contributors was sufficient. Accordingly, please find that reasonable cause exists to charge no penalty in this case.
